MATTERS ARISING

From the EGM on the 14th February 2023:-

The following estimates were received from David Bantoft of the Middle Level Commissioners and after discussion accepted by the Board which directed that the work should be carried out:-

The cost of replacing the thrust bearing of the Stocking fen Pump £4000 + VAT.

The cost of refurbishing the slacker at Stocking Fen with new plate and winding gear £2000 + VAT.

Lattenbury Services will carry out the work at the cost of £500 per day. DISTRICT OFFICER'S REPORT and DRAINAGE PROGRAMME for the current year:

The Board received the Notes of the Annual Drainage Inspection attached and approved the Action Points and Maintenance Programme proposed by the District Officer.

It was noted that the warning signage at Stocking Fen PS had been displayed in accordance with the Health and Safety Consultant's recommendation.

After discussion it was decided that DA be requested to investigate and erect a large gate in place of the single pedestrian gate at the compound at Stocking Fen PS so that it could be opened to allow the skip which catches the spoil cleared by the Weed Screen Cleaner to be removed, taken away and emptied from time to time. The District Officer agreed to clean the stone from the bank over the pathway entrance to the door to the Pumping Station and seed it with grass to preserve the bank.

The points in the Notes of the Annual Inspection concerning the defects in the work on the drainage outfall opposite the Accent Homes/Hill Partnership Development at Stocking Fen had been brought to the attention of Graham Moore of the Planning Department at MLC who is now following the matter up with the developers.
